Course description

This course explores the intricacies of Cantonese grammar through the lens of contemporary linguistic theories. Students will gain a comprehensive understanding of Cantonese grammar, including its word formation (morphology), sentence structure (syntax), aspectual system and sentence-final particles. This course will situate Cantonese within the broader context of linguistic typology, examining how its grammatical structures relate to and diverge from those of other languages in the region and globally. By the end of the course, students will have developed a solid theoretical foundation in Cantonese grammar, enabling them to analyse its complexities within modern linguistic frameworks and appreciate its place in the landscape of the world's languages.

- Demonstrate a comprehensive understanding of Cantonese grammar
- Analyse Cantonese grammar within a typological framework, comparing and contrasting it with other languages in the region and globally
- Appreciate the unique position of Cantonese within the broader context of the world's languages
